- We provide you with patient registration forms - at no charge.
- Patient statements sent monthly.

COSTS AND CONTRACTS

Contract length: 2 year minimum

Billing Fee: Pricing depends upon volume, practice size, services required and determined on an individual basis accordingly.

Primary insurance billing/ Medigap
Patient billing/secondary insurance*

Startup Fees: \$5,000 startup fee (or \$2500 startup fee plus \$2,000 minimum monthly fee)

**Bank Lock Box
Fee:**

Physicians using the billing service are required to have a bank lock box account established for receipt of insurance payments. We recommend that the physician establish a lock box account with their own bank. If the physician is unable to establish a bank lock box, the billing service will assist the physician in establishing an account with their bank.

The physician is responsible for all costs associated with the bank lock box.
